MEMBERSHIP TERMS & CONDITIONS

GENERAL

1. Billing and Registration:

Tactic Membership fees are invoiced on a pro-rata basis shortly after completing the registration. Annual membership invoices are issued every April.

2. Welcome and Membership Portal:

Upon registration, Tactic members will receive a welcome email and access to the Tactic Membership Portal. Tactic reserves the right to modify membership benefits without prior notice.

3. Membership Portal Responsibility:

Members are responsible for updating the Membership Portal with current capability statements and contact details. This information is utilised in the Local Supplier Index, shared with asset holders and major proponents.

4. Contact Information:

Members will nominate a primary contact and an accounts contact for billing inquiries. This designated email contact will receive priority access to Tactic events and offerings.

5. Eligibility:

Membership is open to organisations with a valid Australian Business Number (ABN) or Australian Company Number (ACN).

6. Discretionary Membership:

Tactic's Board and CEO reserves the right to approve or revoke membership at their discretion.

7. Acceptance of Terms:

All members must indicate acceptance of the terms and conditions before their application is processed.

8. Resignation:

Members wishing to resign must do so in writing via email. Refunds will not be provided for any paid funds.

9. Modification of Benefits:

Tactic reserves the right to modify membership benefits without prior notice.

FEES

Membership fees are set annually at the Tactic Annual General Meeting and are determined by the number of Full-Time Employees within the member's Australian operations and are invoiced shortly after the join date.

10. Subsidiary Discounts:

Subsidiary organisations linked to a Tactic Member can receive a 50% discount on their annual fee. For inquiries about group membership offers, contact our membership team.

11. Renewal and Payment:

Membership renewal fees are issued in April each year and must be paid within terms of the invoice. Failure to do so may result in suspension or revocation of membership.

12. Non-Refundable Fees:

Membership fees are non-refundable.

Membership includes cross-promotion opportunities at no additional cost. Members can submit industry news for feature on the website and social media, subject to Tactic's approval.
